#### V. Reports/ Discussion Items

Melissa Crane joined at 6:33 p.m.

A. Legislative Issues: Representative Lance Clow, Terry Ryan, and Anthony Warn - The Board discussed legislative issues with Mr. Clow, Mr. Ryan, and Mr. Warn.

**B. Replication** – The Board held a discussion on the process to replicate and what funding is available.

- C. Lead Teacher/Head of Schools Reports/Student Outcomes
  - 1. Becky Baird- Grammar Schools: She stated that the Jingle and Mingle Craft show was a success, and the Library (K-6) will have new furniture and books for January.
  - **2. Lisa Thompson–Logic School:** She stated that a  $6^{th}$  grade student will be competing in the Patriot's Pen at the state level. She stated that 56 students were hosted in Mr. Moon's office for top sales for Butter Braids. She also stated that she is wanting to schedule college students who attended Xavier to speak to the  $5^{th}$  - $8^{th}$  grades.
  - **3. Brian Loosli Rhetoric School:** He stated that Bill Hamlin will give him some rough numbers in January for building costs. He informed the Board that a new sound system on permanent loan was installed in the gym.
  - 4. Gary Moon Head of Schools: Mr. Moon stated that there is no incentive or advantage to do early accreditation unless the school gets a discount. Xavier had a lockdown drill in November and there are a few areas that will be addressed to help improve the drill. These areas include window coverings and speaker systems added to a few areas in the building. Automatic door locks will be installed during the Christmas break. The digital sign will be shipped and installed next to the modulars in the first part of January. Mr. McNurlin will be going to a shooter training for Xavier. Alternate authorizations have been approved except for one which will be in February.
- **D. PFA Report** Cheri Aiello: PFA bought 150 chairs for Xavier. The next teacher luncheon will include massages. It was also stated that Pizza Pie Café fundraiser will be this week. The PFA is working on a wish list with Scholastic and Amazon for the library.
- **E.** Foundation (Capital Campaign Kick-off) Mr. Hilverda: He stated that he recommends that a fund be created under the schools 501c(3). He stated the Phoenix Fund would need a separate checking account. The Board named two signers for the new checking account: Mrs. Sheryl Liu-Philo and Mr. Hiverda. The Board discussed who the committee should include and stated that a board member, PFA member, school finance member, and parent volunteers should be included. The Board named Mr. Hilverda the chairperson of the Phoenix Fund.
- **F. Grants Report –** Mrs. Dannah Robertson updated the Board on the status of the grants.
- **G. Decennial: Twin Falls Today Itinerary** Mrs. Thompson stated that cold sandwiches and a salad will be served for the Twin Falls Today event, January 10 from 12 p.m.-1p.m. She also informed the Board that the 1<sup>st</sup> grade, Eclatante, and Mr. Moon will be the program for 20-25 minutes. Mel Wiseman will be honored on Arbor Day.
- **H.** Advanced Opportunities AP vs Dual Enrollment: A discussion was held on the pros and cons of AP and dual enrollment.
- **I. Food Service (Kitchen)** Mr. Loosli stated that he had a priority list of items that the kitchen was in need of to improve that area. The Board held a discussion, and it will be brought back next month.
