I. Roll Call Attendance

V. Reports/ Discussion Items

A. Lead Teacher/Head of Schools Reports/Student Outcomes

1. Becky Baird- Grammar Schools: She stated the teachers are continuing their teacher professional development which includes reading a book about James Madison and writing an academic article for future discussion.

2. Lisa Thompson–Logic School: She presented the teacher training schedule. She also stated that she will be reviewing what worked and did not

work regarding homework. She reported Mr. Dickson and Ms. Reyes went to a Singapore Training this summer and will report at the teacher training.

3. Brian Loosli – Rhetoric School: He stated he has been purchasing items to prepare the new classrooms. He also stated the bid for the gym curtain (3 sides and vinyl) was for \$14,000. Maddie Miller received the Spirit of Idaho Award for her Senior Project, which was the Hope for the Homeless Event.

4. Gary Moon – Head of Schools: Mr. Moon stated the teachers are required to come to school for trainings on the Aug 19, and the new teachers will be introduced to the mentor program. Silverback Learning has an evaluation tool that would make the process quick and easy. The Xavier website is almost completed. He met with Lance Clow and Terry Ryan about replication, becoming an innovative school, more freedom for charters to hire, out-of-district IEPs, and tapping into the local levies. They also discussed more freedom for charters to hire and Mr. Moon stated they are in the process of hiring a counselor and part-time administrator and finalizing the schedule for classes offered.

B. PFA Report – Cheri Aiella: She stated that the next meeting will be Sept. 8 at 3:15 p.m. and are going to do a Back-to-School Meet and Greet, Sept. 1 at 4-7 p.m. They will be holding meetings every other month.

C. Foundation – Mrs. Burr informed the Board that there are legal issues with being a foundation and being part of the school. She suggested changing the type of entity from a foundation to funding or making the foundation a separate entity. She also stated that other foundations have an executive director position which would help with the stability of this entity.

D. Registration- Mr. Moon stated that Ms. Stacey Young has compiled the forms and will be sending them out to parents.

E. Construction Update –Mr. Loosli stated that Mr. Kenny Anderson will be installing skirting and ramps in the next week, and the classrooms can be set up after the occupation permit is approved.

F. Traffic Safety – Mr. Kapeleris stated Mike Sullivan said that the pavement will be completed next month. Mr. Sullivan suggested using cones at the busy intersections.

G. Calendar Continuous Improvement Meeting – The Board scheduled to meet Sept 21st from 6-9pm.

The first time the students have below a C average in any class, they will receive a 2-week suspension. The 2^{nd} offense will result in students no longer participating in cross-country for that school year.

She also stated the 1st Federal Grant will be awarded to Xavier Charter School for the purchase of risers for Ms. Hall's classroom.

Whereas, Xavier Charter Schools was granted Idaho charter school status on December 15th, 2006, as the first independent charter serving Twin Falls and surrounding Magic Valley communities; and

Whereas, Xavier Charter Schools has provided a classical education model based on the trivium to students in the Magic Valley for the last ten years; and

Whereas, Xavier Charter Schools' primary mission has been to nurture its students in virtue thus preparing them for every duty of life through recognition of The Good, the Beautiful, and the True; and

Whereas, Xavier Charter Schools has committed to carrying forth the Founding Fathers' hope that American schools teach students how to preserve a constitutional republic; and

Whereas, Xavier Charter Schools has participated in community service that reflects responsible citizenship in a democratic society; and

Whereas, Xavier Charter Schools began with 267 students but today has 683 students enrolled and has graduated 83 students since 2008; and

Whereas, other charter schools in Idaho have struggled financially to stay open due to inequities of facility funding, Xavier Charter Schools has attained financial stability with plans for expansion; and

Whereas, Xavier Charter Schools students have tested in the top 15% on the SAT; and

NOW, THEREFORE BE IT RESOLVED that the Twin Falls County Board of Commissioners shall commemorate December 15th, 2016, as

and call upon the citizens of Twin Falls County to honor Xavier Charter Schools for its success and service to the people of Twin Falls County for the last ten years
