

# XAVIER CHARTER SCHOOL Board Meeting Minutes Location: 1218 North College Road Twin Falls, Idaho 6:00 pm, October 13, 2011

### **Board Items**

PCSC has issued a Notice of Default because the administrator lacked appropriate credentials in the state of Idaho as required by Xavier's charter and Idaho Code. The PCSC required a response by October 18<sup>th</sup>. DBurr will send a response that the defect has been cured with the acceptance of the resignation of the administrator.—

ISBA Administrative Recommendation – Administration made the recommendation to spend \$1,750 to purchase the ISBA's district policy manual and update service to bring Xavier into compliance with Idaho legislation.

JWallace made the motion to purchase. MLambert seconded.
