Jon Goss, Assistant Head of Schools, reported to the board. The transition with the new lead teacher for the secondary level is going well. This role will look different than previous years due to the reduced hours that the lead teachers will be responsible for teaching their own classrooms. Secondary AI Technology awareness was discussed. Best Public High Schools in Idaho from Stacker and Xavier Charter School was rated thirteenth in the state.

Liz Parker, Secondary Lead Teacher, reported to the board. All items on her report are on the discussion agenda.

Hillary Harm, Lower Lead Teacher, reported to the board. The focus has been spent preparing for teacher training. Elementary science curriculum has arrived. The PFA has purchased the non-consumable materials kits for the K-6 science. New teacher onboarding/orientation, there will be 5 new teachers on the elementary end. The new teachers will come in on the 11th. New student testing will happen on August 9th for those that have not yet tested.

Maintenance Report - Gary Moon reported for Brian Loosle. The modular units will arrive on July 24th. There are multiple projects in progress. The school has received two bids to paint over the wallpaper in the hallways. One bid was \$18,000 and the other was \$20,000. Fairbanks Painting will be able to complete the project school starts.

Health Approximately 30-50% of our students are taking health on IDLA and the Xavier class sizes are extremely small. Xavier needs to adopt a health curriculum or offer it through IDLA. The board has asked that the lead team explore getting our own health curriculum.

History – the new history curriculum has arrived. The lead team is concerned regarding some missing time periods and some of the government standards. The team is exploring options on filling those gaps.
